The total implementation of the Company's Series I Warrant Conversion amounted to 19,463,394 (nineteen million four hundred sixty-three thousand three hundred ninety-four) warrants, with the funds received totaling 3.7 billion Rupiah, representing 2.5% of the total Series I Warrant Conversion implementation of 771,239,700 (seven hundred seventy-one million two hundred thirty-nine thousand seven hundred) warrants. Additionally, management has also extended the fundraising plan in the Company's subsidiary until the end of 2024, which was originally targeted for 2023, and adjusted the growth plan based on internal cash flow reserves and cash flow from operations.</i></p> <p><i>Considering the factors mentioned above, management has also adjusted the capital expenditure plan and business growth targets of the Company, refining the long-term strategic plan. These refinements are a manifestation of management's commitment to achieving sustainable and continuous growth.</i></p> <p><i>The adjusted revenue projection outlined above is approximately 60% of the previously communicated target. This adjusted revenue projection still reflects a significant growth rate of 45-50% compared to the revenue in 2022. This growth also drives an increase in the Company's operating profit and net income.</i></p>
